Power of Attorney/ Protection Mandate

- Common Estate Planning Tool
- Often Contentious
- Sometimes Abused
- Frequently Litigated

The Scope of the Power Granted by the Instrument

- What can an attorney do?
- What can't they do?
- How are powers limited?

Qualifications of the Attorney

- Can anyone receive a power of attorney and act on it?
- Can an individual be disqualified from receiving a Power of Attorney?
- Can the same individual receive a POA and be named as an executor of the testator's will?

- Power Struggles: One power, two attorneys.
 - What happens when two powers are granted?
 - Is there a division of power?
 - Are both attorney's authorized to act independently?
 - What if there is disagreement?

Power of Attorney: Taking Effect

- When does a Power of Attorney come into effect?
- When the power comes into effect upon a certain condition, who makes that decision and how?
- Do disputes ever arise between donor and donee of the power regarding capacity?

Power of Attorney: Revocation

- Is a Power of Attorney revocable?
- Can a person with Power of Attorney continue to act while a revocation is in dispute?
- What can or should third parties do to protect themselves during a disputed revocation?

Power of Attorney: Compensation

- Is a person granted Power of Attorney entitled to compensation?
- If so, how are fees generally set?
- What about continued support?

Power of Attorney: Duty to Account

- Does the attorney have a duty to account or other reporting obligations? If so, to whom?
- Who can demand an account or a report? How can it be demanded?
- Does the attorney have any "wrap-up" obligations in terms of reporting?

Power of Attorney: Third Party Considerations

- Are third parties required to act on a purported Power of Attorney?
- If they are, how is that enforced?
- If they are not, what recourse does the attorney have to act in the best interests of the donor?

Power of Attorney: Third Party Liability

 Are third parties vulnerable to liability for dealing with a party purporting to act under the authority of a Power of Attorney that they may later learn is illegitimate or ineffective?

Power of Attorney: Third Party Liability

- What should a third party do to insulate themselves from liability when dealing with a person acting under the apparent authority of a Power of Attorney?
- Is looking beyond the instrument recommended or required?

Power of Attorney Across Jurisdictions

- Are powers granted in one jurisdiction effective in other jurisdictions?
- Should third parties accept Powers of Attorney from other jurisdictions as valid?
- Are there risks in doing so?
